ACEmployment

ACEmployment has surpassed its MSD reporting targets with a final count of 44 placed and supported into employment. We have also made another placement immediately after the MSD reporting period. In total, the people we have supported into employment have worked a combined 41,000 hours and our employment consultants have provided 2,200 hours of support. Some of the employers we are working with include Tip Top, Farmers and NZ Navy.

We are regularly visiting new work places to increase their employer base and foster new business relationships. Our employment consultants are looking forward to the new laptops and software to manage and maintain their workloads.

Expect Success has signed on two new people for our transition service. We are keeping in regular contact with many of the local High Schools and Colleges and have given presentations to the staff and families about the transition process. We are also part of the organising committee for the next *Exploring Futures* Transition Expo. We will keep you posted as this progresses.

Executive Board Members

Judith Fyfe, ONZM, LLB, Vice President

Judith Fyfe has a background in research and communication. Prior to co-founding the New Zealand Oral History Archive she worked in Television as a journalist and in the film industry. Currently Judith practises as a barrister specialising in forensic law.

Judith Fyfe has training and experience in governance in both the voluntary and public sectors. She is a partner in City Associates, a film production company, a former director of Radio New Zealand Limited, a former member of the Arts Board of Creative New Zealand and former member of the Copyright Tribunal the Film and Literature Board of Review and the Medical Council of New Zealand. She is currently on the board of NZ Film Archive. In addition to involvement in a number of community organisations she is a long-time member of the Wellington Medico-Legal Society, the New Zealand Law Society and a trustee of Wellington After-Care Association.

Kevin Carr, Treasurer

Kevin Carr is retired and resides in Wellington. He is a member of the New Zealand Institute of Accountants (CA) and a Fellow of the New Zealand Institute of Management. Kevin has worked in both Government and the private sector in accounting, computers and management. He was General Manager Finance for the New Zealand Housing Corporation for 5 years and then in 1992 when the Corporation was restructured was appointed CEO for the mortgage portfolio of approx \$3.5 Billion and land and buildings of over \$200 million.

Kevin was appointed Financial Secretary of the Ministry of Finance and Economic Management for the Cook Islands Government in July 1998 and retired from that position in February 2007. As Financial Secretary he was responsible for the Treasury, Inland Revenue and Customs, Statistics and Aid Management for the Cook Islands. During 2008 and 2009 he was a member of the boards of the Financial Supervisory Commission and the Public Expenditure Review Committee until appointed as Acting Financial Secretary in March 2010 until October 2010 pending a permanent appointment to the position.
